- This application form is to be used by person(s) requesting an amateur radio license to operate amateur radio in Bhutan.
 - The applicant is expected to have read the relevant provisions of the Bhutan Information, Communications and Media Act 2018, National Radio Rules and Regulations (NRRR) 2021 and licensing terms and conditions before completing this application form.
 - All information fields on this form must be completed. Failure to complete the information will result in the delay in the processing of this application and even rejection of the application.
 - The applicant(s) must submit:
 1. Trade License (If the Bhutanese applicant is a company)
 2. Technical specification of each radio equipment to be used
 3. Copy of existing amateur radio license from home country (if foreign national applicant)
 4. Passport copy and the travel itinerary (if foreign national applicant)
 - The details of the application and corresponding fees are given in the Table A in the last page of this form.
