Terms and conditions for frequency/Apparatus License

A. General

- 1. This frequency/apparatus license is issued in accordance with the Bhutan information Communication and Media Act 2018, the National Radio Rules 2021 and the international Telecommunication Union-Radio Regulation and shall be governed by the above laws.
- 2. The License shall use only the frequency and operate in the area/location authorized in the license.
- 3. This license shall be valid only within the territorial limits of the kingdom of Bhutan.
- 4. Unauthorized additional use of frequency will be dealt and fined by the Authority.

B. Requirements

- 6. The License shall ensure that no radio apparatus used or operated exceeds the specified maximum output powers and emission parameters without the prior written approval of the Authority.
- 7. Unless permitted, the license shall cease operation of all radio apparatus causing harmful interference until such time as the harmful interference has been eliminated.
- 8. The license shall produce the technical details of the usage of the frequency(s) if required by the Authority.
- 9. The license shall cooperate with the inspection and monitoring team, during technical and monitoring inspection by the Authority.
- 10. The license shall register the transmitters with its specifications to the Authority soon after the commencement of radio equipment.
- 11. The license shall assure the safety of human and animal due to the Radio equipment.

C. Renewal and Penalty

- 12. The date of commencement of radio use shall be effect from the issue of the license.
- 13. The license shall renewed annually prior to the expiry of license, however 30 days grace period from the expiry date will be provided.
- 14. Failing to renew the license within the end of grace period shall lead to the penalty fine of Nu. 50 per day.
- 15. If the license is still not renewed within the 90 days from the end of grace period, the Authority will notify the licensee for the cancellation of his/her license which will lead to the cancellation of license and the seizure of Radio Communication equipment.
- 16. The license shall notify to the Authority in written of its intention to cancel the license.

D. Compliance

- 17. The license shall not authorized the third person/organization to operate the radio communications apparatus under the frequency/apparatus license assigned.
- 18. Licensee must comply with all the directions from the authority in relation to the use of the frequency/spectrum.
- 19. The licensee shall not be transferable and cannot be leased out to the third party.
- 20. The licensee shall indemnify the Authority during any of the equipment failure.
- 21. The licensee must comply with all the directions from the authority in relation to the use of the apparatus/frequency/spectrum.
