DIRECTOR'S FOREWORD

It is my privilege to present the Annual Report of the Bhutan InfoComm and Media Authority 2013, the 5th Annual Report since its establishment in 2006. This Report presents the Review of programmes carried out during the period 1st January 2013 to 31st December 2013 and an overview of the ICT, Media and Entertainment Sector in the country. The Report also presents its plans, a way forward to develop the Sector and in pursuit of providing level playing field for the ICT and Media industry in Bhutan.

The year 2013 was yet another fulfilling year for the Authority in carrying out its mandates as a converged regulator. Apart from the normal regulatory functions, the Authority also carried out numerous projects, developed plans, reviewed policies, and conducted researches.

In its continued pursuit to enhancing efficiency and effectiveness of the operations of the Authority, a proposal for the full independence of the Authority was prepared and submitted to the Government for approval. The Authority also initiated the tendering and evaluation of work to fulfill its plan to construct its office. However, due to change in the government priorities, the award of construction work was obliged to be put on hold temporarily.

As per the policy of the Royal Government to provide government services to the citizens efficiently using Information and Communication Technology (ICT), the Authority developed and launched the "Online licensing System" capable of handling applications for licences, renewal and such other functions to reduce the cost and time of service delivery while increasing transparency and accountability.

In the Telecommunications Sector, the 3rd Phase of the rural communications programme was successfully completed. The sector also saw expansion of 3G services in different parts of the country and introduction of 4G by the Bhutan Telecom Ltd. in the Capital and the surrounding areas. "The Frequency Band Plan for 850 MHz for use by third Generation (3G) Mobile Communication System in Bhutan" was also adopted during the period.

On the front of Human Resource Development and Management, the Authority recruited 5 officials while 2 officials were transferred to other government agencies.

This report is prepared with the aim to fulfil multiple roles including, statutory reporting, informing the community and policy makers on the status of the sector and seeking continuous support and constructive feedbacks to further develop this sector into a vibrant industry.

CHAPTER ONE

ABOUT BHUTAN INFOCOMM AND MEDIA AUTHORITY

1. Introduction

Bhutan InfoComm and Media Authority (the Authority) is a converged Regulatory body established under the Bhutan Information, Communications and Media Act 2006 (the Act). The Authority is responsible for regulating the Information and Communications Technology (ICT), and the Media and Entertainment Sectors in the Kingdom of Bhutan.


The Authority is a quasi-judicial body responsible for promoting healthy competition in the ICT, Media and Entertainment Sectors to make these services accessible and affordable to all Bhutanese people.

2. Structure and Functions of the Authority

The Authority comprises of six members including the Director as a member secretary. The members of the Authority are responsible for advising the Authority and approving the rules prepared by the Authority in consultation with the relevant stakeholders.

The Authority headed by the Director has 34 regular staffs working for different divisions. The Director is the Chief Executive Officer responsible for the day to day functioning of the Authority as well as enforcing the provisions of the Act.

4. Members of the Authority

The Authority has a set of competent and dedicated board members to approve rules and such other decisions mandated by the Act.

The Members of the Authority are appointed as per subsection 18 (2) of the Act which stipulates that "The Authority shall comprise not less than five and not more than seven members, one of whom shall be the Director. The members shall be appointed by the Minister on the advice of the Royal Civil Service Commission."

CHAPTER TWO

OVERVIEW OF THE ICT, MEDIA AND ENTERTAINMENT SECTOR

1. Regulatory Instruments

The Authority has so far developed nine Rules and eleven Guidelines/code of practice under the Bhutan Information, Communications and Media Act 2006 and four Regulations issued by the Ministry of Information and Communications to regulate and develop the sector effectively and to provide level playing fields for all operators to compete.



2. Operators/Service Providers

For the year 2013, the Authority did not issue any new Newspaper licence. By the end of 2013, there were 3 ICT Facility Licensed Companies, 10 ICT Service Providers, 7 FM Radio Stations, 11 News Papers and 1 Television Broadcasting Service Provider.


Bhutan Telecom and Tashi Cell are the two mobile cellular service providers of the country.


Figure 3: ICT and Media Service Providers



3. Subscribers

The year 2013 recorded the highest growth rate in the Internet subscribers of 88.64% from the previous year while there was a decrease in the subscription for Mobile Telephony and Fixed Telephony by 2.56% and 1.93% respectively. During the year, the overall tele-density reached 76.80%.






4. Market Share

The incumbent operator B-Mobile of Bhutan Telecom Ltd. still holds a majority market share of 74% in the Mobile Telephony while Tashi Cell has 26% market share. Tashi Cell witnessed an increase of 1.19% of the market share in 2013.

6.3G Coverage

The places within the country that are able to avail 3G services are Thimphu, Paro, Phuntsholing, Wangduephodrang, Gedu, Gelephu, Samdrupjongkhar, Kanglung, Mongar, Damphu, Samtse, Jakar and Trashigang. People can now access internet in the mobile phones.

REVIEW OF PROGRAMMES

1. Online Licensing System

As per the policy of the Royal Government to provide government services to the citizens efficiently using Information and Communication Technology (ICT), the Authority developed and launched the "Online Licensing System" capable of handling applications for licences, renewals and such other functions to reduce the cost and time of service delivery while increasing transparency and accountability. The Online Licensing System was developed and launched on 22nd July 2013 at a cost of Nu. 1000,000.00 (One Million).



The system enables applicants to apply for new or renewal of the Authority's licences and permits online. It also facilities tracking of applications and downloading of e-copy of the licences/permits.

The system can be accessed at **online.bicma.gov.bt** or through **www.bicma.gov.bt**.

Since some of the licensing process involves seeking approvals from the local authorities like the Dzongkhags, Thromdes and Dungkhags, the respective focal persons were trained on the use of the system and were provided with user manuals to orient and guide them in the use of the system. The training of the Dzongkhag/Thromde focal persons was held in February 2013 in Wangdiphordang and Mongar.

2. 3rd Rural Communications Programme

The target for the 3rd phase of rural communications Programme was achieving 100% mobile coverage. Against the target to connect a total of 70 villages, 65 villages were connected to the mobile cellular services by the programme. The three rural communications

programmes have successfully connected all 20 dzongkhags and 205 gewogs availing mobile phone services.

3. Cable TV and DTH survey

The Radio Communications Division organized a Survey on Cable TV and Direct-to-Home (DTH) users in three the locations of Phuentsholing, Paro & Thimphu. Graduates were recruited as temporary enumerators which extended from 14th February to 4th June 2013. The actual subscribers collected by the enumerators are:

Cable SAT Club, Phuentsholing(1476), Tshela Cable, Phuentsholing(1800), Norling Cable, Thimphu (6589), Etho Metho Cable, Thimphu (5754), Nakchung Cable, Thimphu (317), Sigma Cable, Paro (2258) and TD Metho Cable, Paro (904).

4. Inspection on Places of Entertainment in Phuentsholing and Eastern Dzongkhags

To validate public complaints on places of entertainment and to scrutinize entertainment places without valid operating licences, the Media Division deputed officials to Phuentsholing and in the Eastern Dzongkhags.

It was found out during inspection that there were some operating without valid licences; snooker licensees operating with a bar within their premises and some others which were leased to the third party which is against the Authority's directives.

In accordance with the findings of the report, the Authority advised the respective Dzong-khag/Dungkhag/Thromde Entertainment Licensing Committees to suspend its operation and to legalize operation of such places. The snooker licensees were directed not to operate bar within their premises and the licensees were issued suspension order for not complying with the licensing terms and conditions.

5. Fencing of Monitoring Station

With the recent land survey carried out by the National Land Commission, the area demarcation of the Authority's base station at Tsirang was finalized. The the civil fencing work was carried out to demarcate the land falling under the Authority's base station. The

fencing work which began on 14th June was completed on 23rd June 2013.

6. Works for Construction of Head Office

The Ministry of Finance approved Nu. 68,000,000.00 (Sixty Eight Million) for the construction of the Authority's Head office in Motithang out of which 40% of the total approved budget was approved for this financial year. Therefore, the tender was floated for the construction. However, due to sudden change in the government's priority, the construction is still being kept on hold.

7. Review of Public Complaints

The following complaints lodged to the authority were reviewed and actions taken accordingly;

8. Licenses issued

- a) **Printing Licence:** As per section 93 of the Act, the Authority issued 3 new printing licences under the cottage and small firm's category.
- b) **Registration of Books:** A total of 28 books ranging from short stories to textbooks were registered with the Authority as per section 95 of the Act for sale and distribution within the country. (See Annexure 6).
- c) **FM Broadcasting Licence:** With the issuance of one new FM licence to the Yiga FM Radio (94.7 MHz) on 12th December 2013, the total number of licensed FM stations

- in the country is seven including Sherubtse Campus radio (See Annexure 8).
- d) **Filming Permits:** In 2013, 14 national films, 2 national documentary films and 35 international documentary film permits were issued for production within Bhutan. (See Annexure 1 and 2 respectively).
- e) Licences to operate places of entertainment: For the year 2013, a total of 95 entertainment licences were issued by the Authority; 49 snooker licences, 17 video game licences, 5 Drayang licences, 8 discotheque licences, 7 karaoke/live music licences, 1 cinema hall licence, and 8 performing troupe licences. (See Annexure 5).
- f) **Cable TV licences:** With 7 new Cable TV licences issued for the year 2013, the total Cable TV Licenses issued as of 31st December 2013 was 62 in the country.
- g) **Radio licence:** New Radiocom License issued for the year 2013 was 10. A total Radiocom Licenses issued from 2000 till 31st December 2013 accounts to 185.
- h) **Amateur licence:** A total of 6 new Amateur Radio licences were issued from 1st January 2013 till 31st December 2013. The total number of amateur Radio licences issued from 2000 till 31st December 2013 is 120 licences.
- i) ICT equipment Dealer licence: The Authority issued 3 new licences for ICT equipment dealers and as of 2013 there were a total of 9 dealers.
- j) **Internet Service Provider (ISP) licences:** With 2 new licences issued for the ISP, there are a total of 12 such service providers currently.

9. Permits Issued

- a) **VSAT & SITA permits:** The permits issued for VSAT and SITA were 4 and 1 respectively for the year 2013.
- b) **Permit to host reality television show:** One permit was issued to host the Druk Super Star-Season 3 of the Druk Star Production.
- c) **Certification of Films:** Fourteen (14) national films and twenty four (24) international documentary films were reviewed and certified for public viewing by the Authority.
- d) **Accreditation of Journalists:** The year 2013 witnessed many foreign journalists visiting the country particularly with the ongoing elections for the various parties.

A total of 184 foreign journalists and 1 national journalist were accredited by the Authority.

10. Regulatory Enforcements

Following the due process prescribed in the Act and the Rules, the Authority enforced a number of regulatory decisions against non-compliant licensees. The decisions included revocation of a publishing licence; and issuance of show cause orders, cautionary notices and suspension orders against publishing/radio broadcast/entertainment licensees.

11. Meetings and Consultations

- a) **Consultation with the Bookstore Owners:** In keeping with the provisions of the Bhutan Information, Communication and Media Act, 2006 and the rules governing printing presses, books and newspaper,s the Authority held a meeting with the Bookstore owners at the Authority's conference hall on 8th April, 2013. During the meeting, the Authority explained the formalities and procedures for the registration, sale and distribution of books, magazines and newspapers within the country. The Authority also received very useful suggestions from the bookstore proprietors to improve the registration processes.
- b) **Annual Meeting with the Proprietors of the Drayang:** The annual meeting with the proprietors of drayangs was held on 21st June, 2013. Among many points discussed, the meeting focussed on the licensing of cultural performing troupe and some of the concerns expressed by officials and public on the activities of drayangs. The meeting provided useful input to the preparation of draft licensing terms and conditions for the cultural performing troupe. The proprietors of the drayangs assured that they would continue to comply with the licensing terms and conditions signed by them and to educate their employees and the customers on the laws, regulations and rules governing the places of entertainment.
- c) 2nd Consultation Meeting with the Film Review Board Members: The consultation meeting held on 5th December, 2013 with the Film Review Board Members provided an opportunity to present the overview of the rules governing examination and certification of film to the Members. The meeting also provided a forum for the Members to share their experiences on film reviews and discuss specific

- cases that would contribute towards the consistency of future film review decisions.
- d) **Coordination meeting with stakeholders:** Coordination meeting on the usage and assignment of Microwave frequencies (7 GHz and 8 GHz) between Bhutan Telecom & Tashi InfoComm was held on 20th June 2013 initiated by the Radiocommunication Division. The meeting decided that Bhutan Telecom will use upper 7 GHz frequency Band and the Tashi InfoComm will use lower 7 GHz frequency Band.

12. Studies Undertaken

a) Paper on Financial Autonomy: In keeping with the provisions of the Act, the directives of the Ministry and the best international practices, the proposal for "Independence of the Authority" was submitted to the Royal Government through Hon'ble Minister, Ministry of Information and Communications for approval. The proposal was prepared with the main objective of enhancing the capacity of the Authority to effectively regulate all aspects of ICT and media industry by providing a level playing field in the sector for all players to compete and to ensure effective utilization of national ICT, media infrastructure and resources. The proposal was developed in consultation with all the stakeholders and based on independent review by experts from the International Telecommunication Union (ITU).

The proposal defines autonomy as the independence of the Authority to utilize part of fees and charges collected by the Authority and funds appropriated by the Ministry of Finance to finance its strategic plan, outcomes, programs and development of institutional competence without being constrained by conditions of the Government budgetary appropriations and allocation of human resource.

b) Proposal for the New Division of the Authority: In keeping with the Authority's commitment to promote a culture of innovation and strategic planning of its programmes and activities, a proposal to create a new division, "Market Intelligence and Strategic Planning" was proposed with the specific function to carryout planning and research on all policy and regulatory matters. The proposal containing the objectives and justifications for the creation of the division including the need for additional staffs in the division submitted to the Royal Civil Service Commission is still pending.

- c) Research on Problems associated with the Selected Entertainment Places in Thimphu: The Authority conducted a study to validate and understand the nature of problems alleged against entertainment places. The study used multiple questionnaire survey to cover the proprietors and the employees of the entertainment, and the general public. The focus of the study were the drayangs, discotheques, and snookers.
- d) **Policy Review and Compilation of Comments:** The Authority reviewed and submitted its comments on the draft Enterprise Registration Bill (Ministry of Economic Affairs); Policy Document on the formation of Bhutan Media Council; and the Draft Film Policy and the Right to Information Bill.
- e) Frequency Band Plan for use of Worldwide Inter-operability for Microwave Access (WIMAX): In March 26, 2013, the Authority floated a consultation paper titled "Frequency Band Plan for the Use of Worldwide Interoperability for Microwave Access (WIMAX)" technology in Bhutan and was approved and adopted on 30th April 2013. The paper was signed and sealed on 19th July 2013.
- f) **Third Generation (3G) Mobile Communication System:** The paper on "The Frequency Band Plan for 850 MHz for use by third Generation (3G) Mobile Communication System in Bhutan" which was adopted on 10th October 2012 was signed and sealed on 19th July 2013.
- g) Draft Regulation on Appointment of Members and Code of Practice for Registration of Subscriber Identity Module (SIM) Cards: Regulation for Appointment of Members of the Authority and Code of Practice for Registration of Subscriber Identity Module (SIM) Cards by the Service Providers and related stipulations were drafted. The Code of Practice for Registration of Subscriber Identity Module (SIM) Cards by the Service Providers and related stipulations were approved, published and being implemented.
- h) **Study on Digitization of Cable TV network** and way forward for implementation of services was commissioned.
- i) Nationwide Networking of Cable Television through Fiber Optic: Proposal for the Nation wide Networking of Cable Television through Fiber Optic was prepared and published on the Authority's website for comments and feedbacks on 8th August 2013.

- j) **Draft Rules Governing Places of entertainment:** The Authority completed the drafting of the Rules Governing Places of Entertainment. The drafting involved extensive consultation meetings with the stakeholders.
- k) Paper on Direct –to- Home (DTH) users in the country: The Authority conducted a study on the legality of the use of DTH including the extent of DTH use in the country to establish facts and to recommend a way forward to be considered by the Royal Government to resolve pertinent legal and regulatory issues.

CHAPTER FOUR

REVENUE AND EXPENDITURE

1. Revenue Accounts of the Authority




Figure 8: Revenue Balance in different accounts at the end of June




Figure 10: Revenue Share of different Revenue Sources




Figure 11: Distribution of Expenditure




3. Overall Staff Strength


The five broad divisions namely; TeleCommunications, RadioCommunications, Media, Administrative and Finance, Market Intelligence and Strategic Planning (proposed new division) headed by the respective division Chief each and a separate Legal Unit make up the

overall functional divisions of the Authority. The Authority is headed by the director, who directs and manages the regulatory functions of the Authority.

The staff strength of the Authority as of December 2013 was 34 out of which 16 are female and 18 male. Mrs. Tshewang Choden, Assistant Research Officer and Mrs. Ambika Gurung, Senior Communications Supervisor are on study leave.







4. Management and Inter Office Meetings

In order to enhance effective decision making and build on the organization capacities, the Authority instituted monthly inter-office meetings involving all the employees of the Authority; and weekly Management meeting of the Chiefs of the programme divisions to continuously monitor the performance and enhance division specific responsibilities.

5. Trainings

The Authority encourages its staff to attend trainings, workshops, seminars and meetings in Bhutan and abroad as well based on the relevance and usefulness to their professional responsibility. The Authority believes in providing continuous trainings and development opportunities to the staff as a means to improve and enhance the capacity development of the Authority.

CHAPTER SIX WAY FORWARD PLANS

1. Improvement on Online Licensing System

As the number of online applicants increased, a number of limitations of the systems was also identified. At times applicants confronted with the functional limitations while some complained that the system is complicated and needed simplification.

Simplifying the application process was identified as one of the key area requiring improvement. To further ease the tracking procedure, integrating the system with the Census database is also being considered. This will enable the system to automatically complete the details of the applicant once the Citizenship Identity Card number is typed. Additional option for the applicant to upload the approved documents from the local authority rather than processing the approval online may also be beneficial.

Enhancing user-friendliness of the system, incorporating various reporting features, sending SMS alert to Dzongkhag/Thromde focal person about the application received, auto generation of the licence and permit, interface for dealing officials to migrate data, officiating functionality and other such features will be given due importance whereby encouraging more users of the system. The ultimate vision of the system is to enable integration of this system with other information systems in the country.

2. Proposal for the proposed Public Protection and Disaster Relief (PPDR) Regional Harmonization

The Public Protection and Disaster Relief (PPDR) Regional Harmonization frequencies which are: 406.1 - 430 MHz, 440 - 470 MHz, 806 - 824/851 - 869 MHz, 4940 - 4990 MHz, 5850 - 5925 MHz Region three (3) PPDR frequencies are: 380 - 400 MHz, and 746 - 806 MHz dated 8th July 2010 at Tehran, Islamic Republic of Iran is under study by the APT, the outcome which will be finalized by the South Asia Telecommunication Regulatory Council SATRC) Working Group- Spectrum (WG-SPEC).

3. Enhancement of Cable Television Services

The Authority aspires to enhance the cable television services to include other ICT ser-

vices in the near future. The Authority hopes that the result of the cable TV survey and the detailed study commission to an independent consultant will present a detailed information and roadmap for enhancing the Cable Television Services, its converging technology to meet the demands of the changing business model.

4. Monitor, Inspect and Collect Data from Book Stalls

To streamline the sale or distribution of books in Bhutan whether published within Bhutan or otherwise as per section 95, of the Bhutan Information, Communications and Media Act 2006, the Authority will take initiative to register books whether published in Bhutan or abroad with the Authority, institute a system to facilitate the registration process and to make the registration of books available to all the public for reference. The Authority in collaboration with various agencies regulating the entry of goods and services at various check- points will institute an annual audit of compliance to ensure that the voluntary registration system is being fully complied with.

5. Compliance Monitoring

With the enhancement of the capacity of the Authority including the publication of the regulations and rules, the Authority is confident that the compliance monitoring of the ICT and media facility will become efficient and effective.
